Experience Requirements:

(a) Experience under civil works contracts in the role of prime contractor, JV member, sub-contractor, or management contractor for at least the last five (5) years, starting 1 January 2010.

- (b) A minimum number of similar contracts specified below that have been satisfactorily and substantially completed as a prime contractor, joint venture member, management contractor or sub-contractor between 01 January 2008 and application submission deadline:
 - (i) One (1) contract of minimum value of US\$ 13 million (US\$ thirteen million) or equivalent of freely convertible other currencies.

- (ii) Two (2) contracts, each of minimum value of US\$ 10 million (US\$ ten million) or equivalent of freely convertible other currency, but with total value of all contracts equal or more than US\$ 20 million (US\$ twenty million) or equivalent of freely convertible other currencies
